1. FINANCIAL INFORMATION.

Price: The cost of your stay at HaraMara depends on the type of accommodations you select. The prices listed below include accommodations, food, tax, and all yoga instruction (they do not include airfare, travel, gratuity or extra services such as excursions or spa):

Double Occupancy \$1,975
Triple Occupancy \$1,840
Casa Grande \$1,600

Deposit: Reservations are on a first-come, first-serve basis. A **non-refundable** deposit of \$500 is required to hold your reservation.

Payment Schedule: You must pay the balance of your cost no later than December 10, 2010 if you wish to avoid incurring additional fees. If you need additional time to pay your balance later than December 10, 2010, you will incur a payment plan \$150 fee. **If you intend to make incremental payments, you are required to pay a minimum of \$500 (or a minimum of \$1,000 toward your full cost) no later than December 10, 2010 to preserve your reservation. You are required to pay a minimum of \$500 (or a minimum of \$1,500 total toward your full cost) no later than February 15, 2011. Any remaining balance, including any added fees, is due no later than April 1, 2011.**

Cancellations: Your \$500 deposit is non-refundable. **You understand that cancellation of this Agreement with refund is possible only if Sarah and Shaney are able to arrange a replacement for you of equal monetary value. If such arrangement is made, then all but the \$500 deposit monies will be refunded. If no such arrangement is made, you understand that you are obligated to meet the financial requirements of this Agreement. There will be no refunds for arriving to the retreat late or leaving the retreat early. There are no exceptions to the above cancellation policies including personal injuries or weather.**

If the retreat is cancelled by HaraMara, Shaney or Sarah, all deposits and payments to date will be refunded in full. You agree that HaraMara, Shaney and Sarah shall not be responsible for any additional travel expenses incurred in preparation for cancelled retreats including airline tickets, travel delays, flight cancellations or injury/illness.

2. TRAVEL.

You are responsible for arranging your own air travel. Please provide your air arrival and departure information to Sarah Robinette at sarah@tinybench.com no later than March 30, 2011.

You should book your flight into the Puerto Vallarta (PV) International Airport. Unless you plan to stay in Mexico on your own before or after the retreat, please book your flights to arrive at PV on the first listed day of your retreat, preferably arriving before 3PM (PV time), and fly out of PV on the last listed day of your retreat, preferably leaving after 11AM (PV time).

3. GENERAL GUIDELINES.

Release: All guests must sign a "Release of Liability and Assumption of Risk" forms no later than March 30, 2011. If this form is not signed prior to your arrival you will not be allowed to participate in the retreat and no refund will be made

4. GOVERNING LAW.

The terms of this Agreement shall be construed and governed by the laws of the State of Oregon.
